Notes:

- Diplomas and Transcripts issued by foreign institutions of education must be authenticated by the official education services of country in which
 the course was taken and recognised by the respective Portuguese diplomatic authorities or bear <u>The Hague Apostille</u>
- The Transcript of Records must include the grading scale used for evaluation in the institution.
- Academic documents issued in a language other than Portuguese, English, French or Spanish, must be translated into Portuguese by a translator recognized by the respective Portuguese diplomatic authorities.
- 2. For analysis of professional experience identified in paragraph (g), I include:
 - ☐ Updated Curriculum Vitae (in Europass Model), duly signed and dated
 - □ Documents that corroborate the activities mentioned in the CV
 - □ Other documents considered pertinent (for example: Professional Association/Order card, civil responsibility insurance, etc.)
 - ☐ Report that confirms the professional experience and competences that are relevant to the cycle of studies (when, where, for how long and in which context, etc.)
